"Buy a Brick" and help us build a new Boathouse for Gloucestershire

The new Gloucester Boathouse will be a hub for rowing, canoeing and other paddle sports in Gloucestershire and the surrounding areas. The Gloucester Rowing Club and Gloucester Canoe Club will provide access for members of the public of all ages to participate in competitive or recreational rowing and canoeing. The boathouse will also be a base for local universities, colleges and schools rowing and canoeing programmes including University of Gloucestershire, Gloucestershire College, Royal Agricultural College and Hartpury College. British Rowing has designated the new facility to be the regional centre for Adaptive Rowing – rowing for the disabled.

We have already raised nearly £200K to purchase the site for the boathouse and build a landing stage. We need to raise a further £1.5M to complete our project and have recently launched our <u>Buy a Brick</u> campaign.
